Café y Conversaciones, a twice-monthly social engagement activity for Spanish-speaking older adults in the East Metro area. Conducted in partnership with DARTS, a Dakota County human service organization, this program was conceived and requested by the Spanish-speaking older adults who participated in Friends & Co's Community Conversations, and provides a welcoming environment, physical activities and healthy, culturally-specific snacks.

Community Conversations- Community Conversations were conducted in 19 locations and in two languages throughout the state of Minnesota. These focus groups explored the values and concerns older adults perceive while exploring issues related to social isolation. The information gathered is being compiled into a White Paper to help members or the older adult-serving community better understand how people perceive social isolation and community-specific ways it may be addressed.
